Hitachi Appoints Ichiro Iino New Chief Executive for Asia Pacific To accelerate autonomous decentralized global management

Singapore, February 04, 2015 --- Hitachi, Ltd. today announced the appointment of Mr. Ichiro lino as Chief Executive for Asia Pacific who will be responsible to grow Hitachi's "Social Innovation Business" in ASEAN, India, Korea and Oceania.

Mr. Iino will succeed Mr. Kiyoaki ligaya, who is returning to Japan to assume the post of President of Hitachi Document Solutions Co., Ltd. He will also take over the role as new Chairman of Hitachi Asia Ltd. and Hitachi India Pvt. Ltd. from Mr. ligaya.

Both appointments will be effective April 1, 2015.

Under the 2015 Mid-term Management Plan, Hitachi aims to achieve an overseas sales ratio of more than 50%, while expanding business in the global market for its Social Innovation Business. Mr. Iino will develop regional growth strategies, promote localization and will be responsible to effectively utilizing management resources. In addition to having overall responsibility for regional profitability, Mr. Iino will have the authority to make investments in new business areas where growth is expected and will be accountable for achieving positive returns on these investments. This is part of Hitachi's transition to an "autonomous decentralized global management" structure in which each region is able to lead its business autonomously.

Mr. lino most recently served as Managing Director of Hitachi India Pvt. Ltd. and has been proactively expanding business opportunities in India for the past four years as the first Managing Director. In this short period of time, he has successfully transformed Hitachi India into a full-fledge regional headquarter by restructuring the organization to generate new businesses addressing regional needs. He also led Hitachi group companies in the South Asia region under the "One Hitachi" initiative, to provide customers with the full value chain of services as one entity.

In his new role, Mr lino will be responsible for business development in four key areas: healthcare solutions, collaborative solutions with developers and conglomerates, and home appliance business targeting the B2B market, and financial solutions.

"Previously, Oceania and Korea are not under the purview of any region's Chief Executive. The fact that they are now under my responsibility is testament of the growing importance of the APAC region to Hitachi, and proof of how the company is accelerating its globalization and transformation into a global major player. I will work closely with the Managing Directors in ASEAN, India, Korea and Oceania to customize business expansion plans for each region," said Mr. lino.

"The "autonomous decentralized global management" structure is necessary to resolve a variety of global issues that are becoming increasingly complex and borderless. With the autonomy to act as a control tower, I will be able to better develop solutions with Hitachi's customers through "creative collaboration". In addition, I will be able to expand our investments in the Social Innovation Business, where growth is expected particularly for social infrastructure related business to increase our profit," he added.

Mr. lino began his career in Hitachi in 1980 when he joined the company's International Operations Group, after graduating from Hokkaido University with a Bachelor of Engineering. He has since accumulated extensive experience in sales and marketing, and business management in the field of social infrastructure and industrial systems in various positions in his career.

From 2001 to 2004, he was appointed General Manager, Overseas Marketing Department, Mitsubishi-Hitachi Metals Machinery, Inc., a joint venture between Mitsubishi Heavy Industries, Ltd. and Hitachi, Ltd.

In 2004, Mr. Iino was assigned as General Manager, Global Industrial Systems Department, Industrial Systems Sales Division. In 2009, he was Executive General Manager, Industrial Systems and Solutions Division, Sales & Marketing Division, Industrial & Social Infrastructure Systems Company. In these, Mr. Iino played an instrumental role in the development and promotion of the Hitachi Group's sales and marketing strategies of products, services and solutions that impact daily lives and society as a whole.
